

PARTICIPANT WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT
(MINOR – under age 18)

As the legal guardian of the underage participant (the “Minor”), and on behalf of the Minor, I hereby give permission for the Minor to participate in the Group Event on the ice at Landon Arena and related activities sponsored by RoadRunner Hockey, LLC (*the “Event”*); I, for myself, my spouse, children, heirs, guardians, next of kin, legal and personal representatives, executors, administrators, successors and assigns and on behalf of the Minor, freely agree to the following terms pursuant to this Participant Waiver, Release of Liability and Assumption of Risk and Indemnity Agreement (*the “Agreement”*);

1. I warrant that the Minor is *in excellent physical health* with no physical limitations and/or medical conditions which would interfere with his/her ability to safely participate in the Event or endanger himself/herself or others;
2. **I acknowledge that ice skating and hockey are inherently dangerous activities, and I, as the legal guardian of the Minor, hereby expressly assume all such risks and dangers associated with the Minor’s participation in the Event**, which include without limitation, the potential for exposure to extreme conditions and circumstances; contact or collision with other skaters or other natural or manmade objects; imperfect ice conditions; equipment failure, inadequate safety measures, participants of varying skill levels; and other undefined and presently unknown risks and dangers. **I fully realize and accept that as a result of the Minor’s participation in the Event, the Minor may sustain severe and permanent physical bodily injury and/or property damage**, including, without limitation, bruises, scrapes, strained, sprained or torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussions, mental trauma, brain damage, nerve and spinal cord injury, paralysis and death. **I, as the legal guardian of the Minor, willingly and voluntarily accept and assume all such risks of participation.**
3. **I, as the legal guardian of the Minor, agree that it is my sole responsibility to be familiar with the Rules and Regulations established for the Event, and hereby agree to abide by such Rules and Regulations.** I understand and agree that situations may arise during the Event which may be beyond the immediate control of the Event organizers. **I accept sole responsibility for the condition of the Minor’s ice skating and hockey related equipment and if the Minor is under the age of 10, the Minor will wear an appropriate helmet in an effort to prevent injury. I hereby assume all responsibility for the selection of such ice skating and hockey related equipment.**
4. To the fullest extent permitted by law, I, as the legal guardian of the Minor, hereby **Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless, RoadRunner Hockey, LLC, and all of their respective directors, shareholders, officers, employees, agents, sponsors, successors and assigns (collectively, the “Released Parties”), with respect to any liability, claims(s), demand(s), causes(s) of action, damage(s), loss or expenses (including court costs and attorney fees) of any kind or nature (“Liability”)** arising out of or related to this Agreement or the Minor’s participation in the Event, **even if such Liability results from the negligent acts or omissions of the Released Parties.**
5. I hereby pre-authorize the Event organizers and their representatives to arrange for emergency medical treatment and/or ambulance or helicopter transport on the Minor’s behalf if medical attention is warranted during the Minor’s participation in the Event. **I understand and agree that I will be responsible for the costs associated with any such emergency medical care and/or transport arranged on the Minor’s behalf.**
6. I, on behalf of the Minor, hereby grant the Released Parties and their sponsors the perpetual, worldwide right to make both visual and/or audio recordings and still images of me and/or the Minor and to use the name, voice, likeness, picture, words, identity, biographical information or any material based on or derived therefrom of me and/or the Minor in connection with any of the RoadRunners games, RoadRunner-related programming, promotional/marketing materials, and/or other media (collective, the “Media”) and for the purpose of advertising, marketing and/or promoting the Released Parties and their sponsors. On behalf of the Minor, I agree that the rights granted hereunder shall include the perpetual, worldwide right of the Released Parties and their sponsors to edit, telecast, cablecast, webcast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit the Media in any manner and in any medium or forum whether now known or hereafter devised, in whole or in part, without any further compensation to me and/or the Minor.
7. **I hereby warrant that I have read this Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it** (including the rights of my spouse, children heirs, guardians and next of kin), **and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions and provisions of this Agreement.** This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statement or inducements have been made apart from this Agreement. If any portion of this Agreement is held to be unenforceable, invalid or overly broad, the remaining terms and provisions of this Agreement will continue in full legal force and effect.
8. I warrant that I am of legal age, at least 18, and that I have every right to contract in my own name and on behalf of the Minor.
